

Terms and conditions for the 2010 Primelocation.com International Property Poets

1. This competition is run by The Digital Property Group (The Promoter).
2. Under 16s must obtain permission from a parent or guardian to enter.
3. The competition is not open to employees and families of The Digital Property Group or anyone else connected with the creation or administration of the competition.
4. By participating in the competition, you consent to The Digital Property Group disclosing any personal information submitted by you to the Promoter for use by the Promoter and its authorised agents as necessary to administer the promotion. Any personal data submitted by you will be used solely in accordance with current UK data protection legislation and the privacy policies of The Digital Property Group. The Digital Property Group has the right to publish entries.
5. The Promoter takes no responsibility for entries lost, delayed or incomplete, or incorrectly tagged.
6. The competition will run daily from 12th April to 16th April inclusive. The property for each day will be announced on <http://www.primelocationblog.com/international> by 10 A.M on the day of the competition. Entrants must submit a Tweet in English, including the specified hash tag, describing that day's property. Entries must be received by 10 a.m GMT on the following day of the competition to be eligible.
7. Winners will be selected from all the valid entries received by the Promoter. There will be a maximum of one winner per day (so a maximum of 5 winners in total). The judges will select a single winner from each day's competition based on inventiveness, originality, artistic value and quality.
8. Daily Winners will be announced by 2pm on the next working day after the competition has closed and be posted on the Primelocation International blog.
9. The decision of the judges is final. No correspondence will be entered into.
10. An overall winner will be selected by public vote on PRIMELOCATION INTERNATIONAL BLOG. The public vote will open on 19th April and run until Wednesday 21st of April.
